

COMPETITION TERMS AND CONDITIONS

1. Introduction

1.1. By entering the competition, participants agree to be bound by these terms and conditions.

2. Eligibility

3. How to Enter

3.2. To enter the competition, participants must submit a photo through the designated portal ([Photo Competition Entry Form - Apunipima](#)) including a description of the photo, their name, phone number, email address and community.

3.3. Multiple entries are not allowed.

4. The Prize

4.1. The prizes consist of 3 x 'Wanderer Premium Cooler Arm Chair' camping chairs.

4.2. The prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or any other form of compensation.
